

Welcome to the Flood Warden Autumn Newsletter 2023!

Over the next few days, we are expecting more rainfall associated with Storm Ciarán. There is still some uncertainty about the track of the storm, but catchments are already saturated and we are likely to see widespread bands of heavy and persistent rain. The Met Office has issued yellow warnings for wind and rain for the south west from tomorrow until Thursday (1 and 2 November) and an amber warning for very strong winds along the south coast on Thursday (2 November). We are likely to see impacts across the patch in particular to our coastal communities.

Across Wessex, we expect more Flood Alerts and Warnings to come online over the next few days with expected high tides, rising river levels, and groundwater recharging through the catchment.

We have staff on duty 24/7 closely monitoring the situation. Both of the Environment Agency incident rooms are open, in Bridgwater and Blandford Forum. We have briefed our partners in the Local Resilience Forum and will keep stakeholders, partners and communities informed.

Our advice to the public is to:

- Stay safe and not enter floodwater.
- Stay away from seafronts, quaysides and jetties, due to the risk of overtopping by waves.
- Call Floodline on **0345 988 1188** for updates on flooding, to sign up for flood warnings, or to report flooding.

Ground Water Update

Levels are rising across the Chalk in Dorset & in the Vale of Wardour, but more slowly on Salisbury Plain. By the beginning of next week, three or four areas will be likely to meet Flood Alert criteria.


Firstly, a very wet spring pushed levels back up through May and early June and the rather miserable summer has led to the water table being several metres higher than we would normally expect in early October.

October has seen similar rainfall totals to last year, but when combined with the higher start point, we have reached 83.5m at the Woodyates National Indicator Site - a whole month earlier than last year. It is likely that Groundwater Flood Alerts will be in force in West Dorset and Cranborne Chase by the second week of November.

It would be a good idea to check your pumps if you have them.

It is an opportunity for communities to find out how to be better prepared and build resilience through the Groundwater Flood Warning Service, Property Flood Resilience (PFR) measures that are suitable and effective for groundwater flooding, together with details about Natural Flood Management.



Please note these events are being held at hub locations across Dorset and Wiltshire so will not be focussing on individual issues from the groundwater flooding. There will be short break mid-way when guests will have the opportunity to speak with representatives from the various agencies and raise any queries.


Recent Flooding

September Flooding 2023

Since our last newsletter we have again seen exceptional amounts of rain fall in a very short space of time, resulting in flash flooding. On Sunday 17 September, intense thundery rainfall resulted in flooding in West Somerset and parts of Dorset. Our partners at the Fire & Rescue service received over 100 calls and initial reports

Large volumes of surface water flowed across land and roads causing flooding. The Washford River, the Doniford Stream and the River Tone also rose, and we issued flood warnings and alerts in response. Our field teams cleared trash screens, checked our assets, and responded to reports of blockages.

Recent research by the Met Office show that the frequency of extreme rainfall events (more than 20mm/hour) is increasing across the UK. More than ever, we need to be prepared for more events such as those that we've seen in Wessex this year. We will continue to support communities to be as prepared as possible for flooding, and continue to work closely with our partners to help communities recover after flooding occurs.



Surface Water Flooding - September 2023



A surface water flood event occurred in the early hours of 17th September 2023. 25mm of rain fell within one hour and was equivalent to a 1 in 25 rainfall event, so was relatively extreme. Dorset Council, as the Lead local Flood Authority, have received no individual reports from this report, despite informal observations from the community that some properties had experienced flooding.

We would like to encourage flood reporting as it helps us better understand the impacts and can provide evidence for potential future identifiable viable schemes. Reporting can be property specific or based on a local area identified by a flood

Report Flooding

Reporting flooding in properties helps us to map where the issues are. We can then use this information to concentrate resources to where they are needed, better inform development and apply for Government funding to reduce the risk of future flooding.

There is an easy online form, and there is no time limit. Often when this happens to you the last thing you think about is reporting it. But when you can, the information we collect is very useful.

Should I still sign up/remain signed up to the Flood Warning Service?

the seas where there is an immediate threat to life and will supplement a Severe Flood Warning message. You need to be registered to the Flood Warning Service in order for us to contact you and warn that your property could be affected by flooding. This means you will get the latest information, wherever you are, by mobile, text and email.

In addition, the Environment Agency's Flood Warning Service is more targeted to those in flood risk areas, where as Emergency Alerts will be sent to phones on 4G or 5G within reach of the mobile tower in the areas of concern.

Environment Agency Hydrometric Data Explorer

This application provides access to Environment Agency open hydrology data: river flow, river level, rainfall and groundwater level readings for open hydrometric stations and water quality data from our water quality units for open and historic sites throughout England.

Data can be downloaded in CSV format or by using an API (application programming interface). More information about this can be found on the <u>API documentation page</u>. Raw data is uploaded on a regular basis and replaced by checked data once plausibility checks have been completed. Winter Preparedness

Advise the drainage team if there has been internal property flooding in your community. Take photographs and as much detail as possible. Contact drainage@wiltshire.gov.uk

As the year progresses we may experience heavy, prolonged or short intense rainfall events. If you are concerned about roads flooding and/or that need to be closed, blocked gullies or drains causing internal property flooding or standing water on a high-speed road (60 mph), contact either our customer service team by phone 0300456 0100 or use My Wilts https://www.wiltshire.gov.uk/mywilts-online-reporting

Use the discretionary gully tanker service and ask the parish steward to prioritise drainage assets when wet weather is predicted.

Staff endeavour to cover known hotspots but cannot be everywhere. The information you provide us enables us to target resources where they are most needed.

Check your flood plans are up to date along with your contacts. Encourage residents to check the flood risk to their properties and to take steps to protect themselves, and their families. Contact renate.malton@wiltshire.gov.uk for more information.




